NOTICE TO PLAYERS

The Rules of The United States Golf Association Govern Play. This Information Supplements the HSJGA Hard Card.
Unless Otherwise Noted, The Penalty for Breach of a Local Rule or Condition is:
Match Play – Loss of Hole Stroke Play – Two Stroke Penalty

TERMS OF THE COMPETITION

FORM OF PLAY: 36 - Hole Stroke Play

FORMAT: The HSJGA Junior Tour Series is a 36 – Hole competition consisting of two (2) 18 - hole rounds. In the event any round must be shortened due to weather or pace of play, each 18-hole round will consist of four (4) stipulated rounds: Holes 1 - 4, 5 - 9, 10 – 13, 14 -18. (Determined in the order of hole daily started)

TEES: **WHITE:** Boys 13-14 **RED:** Boys 11-12, Girls 13-14 **GOLD:** Boys 7-10, Girls 11-12

TRANSPORTATION: Approved Shuttle Locations: Hole #9 Green to Hole #10 Tee

SCORECARDS: The player is considered to have returned his scorecard when they have left the designated scoring area.

TIES: All ties will be broken using USGA Rules of Golf recommended method.

LOCAL RULES

OUT OF BOUNDS: The following will be played as Out of Bounds during the play of that hole only.

- Right side of Hole # 1 **NOTE:** During the play of any other holes the stakes are considered movable obstructions

PENALTY AREAS: On the left side of Holes #15 & #16, the chain link fence defines the margin of the Penalty Area and is an immovable obstruction. Relief under Rule 16.1b is available for a ball that lies outside of the Penalty Area only.

HEIAU – NO PLAY ZONE: The area defined by green stakes to the left of Hole #16 is a No Play Zone that is to be treated as an *abnormal course condition*. Free relief must be taken from interference by the No Play Zone under Rule 16.1f.

PACE OF PLAY: Players shall always play without undue delay.

First offense - **Warning**; Second Offense - **One Stroke**; Third Offense - **Two Strokes**; Fourth offense – **DQ**
